Indian independence on 15th August 1947.

Let me provide you the near translation of selected lines from my Kannada poem "Bharatha" published in the year 2012 in the book titled Parivarthane:

> India rich heritage of god's love; The land of overflowing culture and humanity, Abode of

abundance Dharma. It's the frontline of humanity,

The Sacred civilization immersed in the ocean of knowledge gifted by the rishis.

It's completeness of great epics, the Mahabharatha and Ramayana. It's Temple of the world in fullness of Vedic wisdom;

It's the history of incarnations in the land of salvation from the vision of infinite truth, Land of pancha boothas the heaven on earth.

A land of Yaga and Yoga, a lovely, pleasant entertaining humane citadel of the world, a land of divine environment protecting unique identity;

A land of gushing fertility, strength and energy, a land of justice with 'supreme constitution' of equal opportunities.

A land of science and technology, in absolute possession of peace and prudence.

Land of dignity filled with patriots, a model of evolved human science fully independent.

A land of indigenous all-round progress aimed at human development.

A land of love, compassion and equality. A land of freedom where people are united by hearts, a land of miracles, the creators wonder, most respected in the world.

A land made out of all the goodness of rivers, range of beautiful mountains, marvellous terrains, a beauty at its best.

The land of greatest civilization, the land of Himalayas with the richness of oceans referred as peninsula that's the India.

It's one and only India where the patriotism is our way of life.

Having defined India my nation as above, it becomes my paramount duty and responsibility to respect Indian independence in its original intent, abide by the Constitution and respect its ideals and institutions, the National Flag, the National Anthem, to cherish and follow the noble ideals which inspired our national struggle for freedom, to uphold and protect the sovereignty, unity and integrity of India, to value and preserve the rich heritage of our composite culture, to protect and improve the natural environments including forests, lakes, and wildlife and importantly to defend my country's respect and dignity.

Before writing you, as a preparation I have carefully enabled my thought

process, conducted reasonable research in cross section involving various religions spread across the country, discussed with freedom fighters, and hundreds of people, because I am fully aware of the quality time management of Prime Minister of largest democracy in the world.

Please understand, I never wanted to push you into a difficult situation by repeatedly writing this, if this was not a 'nationally' compelling high-priority crucial issue. I am left with no other options as I have to act to alert you and create awareness amongst my fellowmen. I have spent sleepless nights, weighed the pros and cons to arrive at a sensible decision. That is the reason, nothing could stop me in approaching you again and this time in format of this book. I have taken the lead to write this letter to you. After all, achievement should have progressive beginning. I consider that my mother land India has given me

With my above quote, trust me at the end of this letter you will fully and gracefully agree with me. I am sure that this nation will then undergo a tremendous and long awaited definitive positive change of high patriotic order that the generations will remember as a patriotic event in independent India.

It's not that I am addressing you on burning problem within the administrative system of the government and its organs. I am also fully acquainted myself with every positive change that my country has undergone since independence. However, the present subject I am dealing is indeed very critical and we are in an emergency situation.

The history should not be allowed to be tampered, however, the national practices highlighting the sadistic British rule as positive sign and as a symbol of bravery is a national shame. We must not forget that 'Satyameva Jayate' meaning 'Truth alone triumphs' is a mantra from the ancient Indian scripture Mundaka Upanishad. On independence, we have adopted this as the national motto of India. It is inscribed at the base of the national emblem.

We cannot offend our courageous freedom fighters, the saviours of our nation. Slavery is a shame, the practice of admiring British practices is a painful feeling of humiliation and we must get rid of the problem as quick as possible.

'Do it now to survive respectfully & sustain dignity or keep quiet and die horribly little latter'

Hence, as a citizen who voted for you expect to carve out some of your time. This due demand, I think is well within my right to address on this national priority.

There is no wonder as to why I have addressed this letter to you, as Prime Minister of India, you are the head of the Government and decision maker, prime decision-making bodies run under your aegis and supervision. You are our prime minister, leader of the parliament and face of our nation. Above all I believe you are a patriot and staunch proponent of Indian values, it's rich culture and heritage.

Before going to the crux of the matter, I express my adoration to you for having recognized yourself as people's prime minister. It is apt at this juncture to recall your popular quotes as follows:

- I might live miles away from you, but I do understand your issues.
- We are not here for any positions but for a responsibility.
- We fought for freedom together.
 We had no government, no weapons to help us. We defeated such a big empire without any government without any arms.

On the occasion of 71st Independence Day Celebrations at Red Fort, on August 15, 2017 you have emotionally addressed India and Indians as

"From the ramparts of Red Fort, on behalf of our 125 crore countrymen, I bow and pay respect to all those men and women who have sacrificed their lives, who have undergone immense sufferings and made

sacrifices for the independence, glory and pride of the country"

Kindly accept my heart felt salutations for your strong message expressing your deep concern for the sacrifices rendered by patriotic independence fighters and for the importance of freedom"

In this background, with absolute clarity, I place on record of my deep rooted disappointment on the government of India for its failure in fulfilment of our cherished independence values, Constitutional hopes and basic expectations of our motherland India especially in Indian Defence Forces, Indian Police and Indian Railways.

Kindly take note that erstwhile governments in independent India and your present government has displayed unpatriotic pessimistic attitude by behaving unconstitutionally in specific reference to Indian Defence Forces, Indian Police and Indian Railways.

It is minimum expected, that the government of India should be ever ready and capable of exhibiting the spirit of Indian independence in it's administration and governance but in government's contrast continuous undemocratic repressive colonial subscriptions are directed at degrading our nation and insulting the very basic fundamentals of our freedom. The admiration and respect accredited to British raj defeats the very purpose of Independent India. Legalizing the atrocious practices of cruel barbaric colonial British Raj in India has caused doubts on the abilities of government of India in protecting the cherished values of independence.

In order to prove my claim, I draw your attention to the negligent acts of Union Government, Ministry of Defence,

Ministry of Railways, Home ministry and its connected state agencies and establishment's which have adopted to Pro-British colonial practices. That is to say, right from Indian Independence every successive government by default has adopted British admiration Policy with constant self-destructive, self-defeating actions and activities of degrading my motherland's Image and Status. Irrespective of parties that were in power, every government has failed to recognize the actual object of Indian Independence in republic India.

As an Indian, I am unable to tolerate the insult meted out to my country and countrymen by our own stupid acts, it is unfortunate that government of India is promoting by continuous gratification, glorification and ratification of the uncivilized brutal blood thirsty British invaders legacy in Indian independence rule of post democracy.

This is unbelievable reality which has far-reaching negative implications on the minds of Indians especially of those in the Defence, Railways, Postal and Police who are forced to periodically celebrate various days in praise of previous British colonial practice. It looks we are caught in a vicious practice of self-destruction of our Identity.

Believe me this has resulted in defaming India Internationally. This ignorant careless attitude of Government of India is shameful, awkward and is against the very basic Constitutional provisions guaranteed to the citizens of our country in independent democratic India.

How can the democracy meaningfully survive with the characters of slavery and symbols of oppression? I hope you will not differ when I say There is no democracy without freedom and there can be no freedom without democracy, both democracy and freedom is functionally inseparable ever'. In order to derive true meaning of Indian democracy it is necessary to weed out the poisonous British practices from the nectar of our freedom.

In this specific reference, the conduct of Government of India has caused severe loss of dignity and respect of Indians in their own nation. Indian citizens are subjected to insult internationally giving an impression that India is still British overseas territory. To be more precise, those acts of praising the horrible British rule in democratic free India is a threat to the integrity of our country as it creates a lasting negative impression on our Defence forces, Indian Railways in particular and on every Indian in general.

Evidently, these thoughtless approaches of Government of India have caused enormous confusion

amongst public in understanding independent India resulting in internal disturbances. This is slowly brainwashing Indians to accept British Raj as superior and humane.

Furthermore, Constitution of India came into force on 26 January 1950, it repealed the Indian Independence Act, by this India clearly ceased to be a dominion of the British Crown and became a sovereign democratic republic. Being so, above acts of hailing and praising the British by the government of India goes diametrically opposite in direction to our valued freedom. At the same time, aforesaid bad practices are against the intent of Indian constitution which specifically violates Art 14, Art 18, Art.19, Art.21, Art.38, Art 51-A, Art.355, Art.395 of Indian Constitution, Prevention of Insults to National Honour Act, 1971 and Civil Defence Act 1968.

Let us examine as to how the government has violated the above provisions of law and the constitution of India.

Equality is one of the magnificent corner-stones of the Indian democracy, Article 14 of the Indian Constitution provides for Equality before law and states that the State shall not deny to any person equality before the law or the equal protection of the laws within the territory of India, Prohibition of discrimination on grounds of religion, race, caste, sex or place of birth. While that holds good, the acts of forcing Indian military personnel to celebrate the British rule in independent India is undoubtedly is against Article 14 as it clearly aimed at breach of equality before law.

Article 18 of the Indian Constitution prevents the state from confirming any title except military and academic distinction within the meaning of independent free India. Article 18 also prohibits Indian citizens from receiving titles from any foreign state. Under the scope of Article 18 in a true democracy, It must be understood that there is no space for British awards, titles and distinctions in Indian society. It is embarrassing to mention that even today the glorification of British titles and honours which were prevalent in British India is not abolished.

The primary purpose of Article 19(2)(3)&(4) of the constitution of India is made in the interests of the sovereignty, integrity and security of India, the state can enact any law that imposes "reasonable restrictions" on the exercise of the rights mentioned in Article 19. Such being the case the government of India's practices in sanctioning the horrifying celebrations in praise of British at Indian defence forces is nothing but act against sovereignty, integrity and security of India.

Article 21 of the Indian Constitution guarantees the right to live with human dignity, free from exploitation. That is also to mean free from exploitation from hailing brutal British policies. In this regard, the state is under constitutional obligation to see that there are no violations of the fundamental right of Indians in experiencing their freedom absolutely free from the traces of slavery and oppression.

Under Article 38 of the Indian Constitution, the State is bound to secure the social order for promotion of welfare of the people. 38(1) directs the State to strive for promoting the welfare of the people by securing and protecting as effectively as it may bring a social order in which justice, social, economic and political, shall inform all the institutions of the national life. While that is the case, evil practices of complementing British rule in India are resulting in damaging social order,

therefore the acts of the government in this reference is against the said article.

Article 51A provides for fundamental duties. It highlights the importance of duty of every citizen of India 51(a) to abide by the Constitution and respect its ideals and institutions, the national Flag and the National Anthem; 51(b) to cherish and follow the noble ideals which inspired our national struggle for freedom; 51(c) to uphold and protect the sovereignty, unity and integrity of India; 51(d) to defend the country and render national service when called upon to do so; 51(e) to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women; 51(f) to value and preserve the rich heritage of our composite culture; 51(g) to protect and improve the natural environment

including forests, lakes, rivers and wild life, and to have compassion for living creatures; 51(h) to develop the scientific temper, humanism and the spirit of inquiry and reform; 51(i) to safeguard public property and to abjure violence. In this context, even though Citizens are morally obligated by the Constitution to perform these duties the government of India has become a bottle neck.

Article 355 of the Constitution of India clearly entrusts the duty upon Union to protect the states against "external aggression" and "internal disturbance" to ensure that the government of every State is carried on in accordance with the provisions of Constitution. However, the heinous practices of paying tribute to British rule in India are creating internal disturbances which are dangerous to the unity and integrity of our nation.

The Article 395 of Indian constitution effectively replaces the Government of India Act and Indian Independence Act of the brutal British government in India. This article provides perfect sanction by constitution of India becoming fully independent democratic country. With this article India ceases to be British-controlled colony and forms to an independent sovereign country. As against this article shamefully government of India is commemorating the inhuman acts of British rule in various important departments of the government. In the issue of Young India of dated 29th March 1931, Mahatma Gandhi wrote as follows:


"Bhagat Singh and his two associates have been hanged. The Congress made many attempts to save their lives and the Government entertained many hopes of it, but all has been in a vain.



"Lest we forget, there are lakhs of ways for survival; It's nothing but the heights of patriotism that makes a soldier".


For that reason, I call upon the government to shun the present practices of acclaiming British Raj and deal with the Defence forces patriotically and emotionally which is


2. In the year 2017 Indian Army's First Battalion's 200th year completion is celebrated with much pomp and show.

There is an ignorant foolish impression that Indians railways were a departing gift by the British to independent India. The present generation is being misled by false and malicious information which is aided and abetted by none other than our own government.

The Intent of British railways in India was never public transport and to

encourage domestic Indian internal transport of goods but to secure their absolute control across India on agricultural cheaply extracted resources and raw materials such as coal, iron ore, cotton, etc., to the ports for transportation to Britain for use in their factories. Although, transporting of people was major source of profit for Railways and therefore the British allowed people to commute in trains that too in third-class compartments in which Indian passengers were treated as untouchables and loaded like that of animals.

History is still fresh in the minds of Indians; Racial discrimination was an inherent quality of British therefore Mahatma Gandhi's first crusade on his return to India was on behalf of the third class travellers of railways. It's a fact, that rouge merchants of British had safeguarded themselves with lowest goods transportation costs said to be the lowest in the world in those

times. The irony is that the Indian passengers who travelled as untouchables in third class bogies attached in the end of the trains paid his sweat money for the profit of railways.

The bold Bengali newspaper 'Samachar' aptly wrote on 30th April 1884 that 'iron roads mean iron chains for India'; the paper further elaborated that foreign goods could flow more easily by killing native Indian industry and increasing Indian poverty.

It can be recalled that Indian super mechanics in the year 1878 had mastered the art of designing and building their own indigenized locomotives. This turned out to be a biggest obstacle for British railway business; the Indian made locomotives gave a tough competition to that of Britain made in terms of cost and quality. Jealously inflamed British men unable to bear the rise of local

industries, in 1912 shamelessly passed an Act of Parliament, clearly making it impossible for Indian workshops to design and manufacture locomotives. This Act prohibited Indian factories from doing the work they had successfully stabilized by sincere and hard work for nearly three decades. This arbitrary law resulted in breakdown of domestic industry. Between 1854 and 1947, British in India imported more than 20,000 locomotives for premium and fancy price tags at the cost of Indians.

meantime the fight In the independence attained high levels, especially after the infamous Simon commission arrived in 1927 supposedly to bring in constitutional reforms in Britain's most important and profitable colony. Knowing well the crocked plans of British, Indians started 'boycotting of the Simon Commission'. On 30 October 1928, the Commission arrived in Lahore where it was met by peace loving protesters waving black flags expressing their displeasure over the unacceptable acts of British, prominent freedom fighter and great patriot Lala Lajpat Rai who had moved a resolution against the Commission in the Legislative Assembly of Punjab in February 1928 was leading the said protest against the commission at Lahore. British police force under the crown's order charged the peaceful protestors in third degree and Lala Lajpat Rai was one of the several who succumbed to the grievous injuries suffered at the hands of British Police as a result of demonized police action on Nov 17, 1928.

Post the death of patriot Lala Lajpat Rai, there was spontaneous surge in India's fight for independence; the independence movement grew rapidly and radically, British sensed all round pressure mounting up and attacking them from breadth and length of India. The British intelligence in India had

reported to the crown that their days were numbered. British Raj realizing the worsening situation resorted to 'loot as much as possible and as quickly as possible'.

While India became independent what remained in India was left-overs of railway which was in worst severe depleted condition.

My claims are not fictional but tested truth and fully protected with genuine historical facts. Many 19th century Indian nationalist economic thinkers and even elite Englishmen who were against the acts of British in India had questioned Britain's bad motives for introducing railways to India.

The most negative aspect of the railway policy pursued by the British authorities is reflected in the absence of consequences on the local iron industry, as the companies procured their supplies from Great Britain for all the necessary equipment (engines, wagons, rails, track equipment) and did not encourage the development of local suppliers. With the end of the 'railway boom' in England, the British railway industry thus found in India a surrogate market for its products, a market that it was determined to safeguard. The bulk of the qualified staff necessary for the smooth functioning of the network (engineers, engine drivers, workshop technicians, etc.) also came from England, so that the railways did not play the role of an industrial school as it had done in a number of European countries.


